Attachment to Articles of Incorporation of Base Camp Jax Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To provide meals at reduced rates, weekly cleaning services of adaily laundry services, and overall comfort and stability are our main goals at this time.

No part of the net earnings of this organization shall inure to the benefit of, or benefit of, or distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for seven rendered and to make payments and distributions in furtherance of the purposes set for herein.
