ARTICLES OF INCORPORATION FOR BIZLIFE EDUCATION CORPORATION

By these Articles of Incorporation (the "Articles"), the undersigned Incorporator forms a corporation 'Not For Profit' in accordance with Chapter 617, Florida Statutes, and pursuant to the following provisions:

ARTICLE I NAME

The name of the corporation shall be BIZLIFE EDUCATION CORPORATION. For convenience, the corporation shall be referred to in this instrument as BIZLIFE EDUCATION.

ARTICLE 2 DURATION

This corporation shall exist perpetually unless and until dissolved according to law. The Corporate existence shall commence upon the filing of these Articles with the State of Florida, Department of State.

ARTICLE III DEFINITIONS

The following words shall have the definitions set forth below for the purposes of these Articles:

- 3.1 "Articles" shall mean these Articles of Incorporation.
- 3.2 "Board" or "Board of Directors" shall mean the Board of Directors of the Corporation.
 - 3.3 "Bylaws" shall mean the Bylaws of the Corporation.
- 3.4 "BIZLIFE EDUCATION" shall mean and refer to BIZLIFE EDUCATION CORPORATION, a Florida corporation not for profit, its successors and or its assigns.

ARTICLE IV PRINCIPAL OFFICE

The principal office of BIZLIFE EDUCATION shall be 1150 Louisiana Avenue, Suite 6, Winter Park, FL 32789.

ARTICLE V REGISTERED OFFICE AND REGISTERED AGENT

Meggan E. Wallander, whose address is 1150 Louisiana Avenue, Suite 6, Winter Park, FL 32789, is hereby appointed the initial registered agent of BIZLIFE EDUCATION and the registered office shall be at said address and who accepts the appointment as registered agent for BIZLIFE EDUCATION.

ARTICLE VI PURPOSE AND POWERS OF THE CORPORATION

BIZLIFE EDUCATION shall have all the powers, duties and benefits of a non profit corporation organized under the laws of the State of Florida, subject only to such limitations upon the exercise of such benefits and powers as are expressly set forth in these Articles or the Corporation's Bylaws. BIZLIFE EDUCATION shall have the power and duty to do any and all lawful things which may be authorized, assigned, required or permitted to be done by these Articles and Bylaws, and to do and perform any and all acts which may be necessary or proper for, or incidental to, the exercise of any of the duties or powers of BIZLIFE EDUCATION for the benefit of the Directors, Officers and Members.

The purpose for which BIZLIFE EDUCATION is organized is exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

BIZLIFE EDUCATION'S mission is to educate all who wish to attend sessions on the arts of small business management, entrepreneurial skills, and the essence of economics, accounting, management, marketing and finance. U.S. Veterans, impoverished individuals (those qualified for Medicare, Food stamps, et al) and physically handicapped individuals shall be admitted without charge.

Notwithstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provisions of these Articles, this organization shall not discriminate on the basis of race, creed, religion, familial status, sex or disability as interpreted under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law, or shall be distributed to the Federal, State or Local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the State in which the principal office of the organization in then located, exclusively for such purposes.



ARTICLE VII BOARD OF DIRECTORS

The affairs of BIZLIFE EDUCATION shall be managed by a Board of Directors, initially consisting of 3 to 5 directors, whose number may be either increased or decreased from time to time by Amendment to the Bylaws of BIZLIFE EDUCATION, provided that there shall always be at least three directors. Directors shall be elected, appointed and removed as provided in the Bylaws of the Corporation. Nothing in these Articles shall be construed to preclude the directors from serving the Corporation in any other capacity and receiving compensation therefore. Directors, as such, shall receive such compensation for their services, if any, as may be set by the Board of Directors at any annual or special meeting thereof. The Board of Directors may authorize and require the payment of reasonable expenses incurred by Directors in attending meetings of the Board of Directors. ARTICLE VIII VOTING RIGHTS AND RULES OF ORDER

Each Director shall be entitled to one vote. Except as provided for in these Articles or BIZLIFE EDUCATION's Bylaws, all meetings, business and otherwise, of BIZLIFE EDUCATION shall be governed by Robert's Rules of Order.

ARTICLE IX OFFICERS

The affairs of BIZLIFE EDUCATION shall be administered by the officers designated in the Bylaws. The officers shall be elected by the Board of Directors at a meeting designated for such purpose, and they shall serve at the pleasure of the Board of Directors.

ARTICLE X INDEMNIFICATION

- Every Director and every officer of BIZLIFE 10.1 Indemnification. EDUCATION shall be indemnified by BIZLIFE EDUCATION against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him or her in connection with any proceedings whether civil, criminal, administrative or investigative, or any settlement of any proceeding, or any appeal from such proceeding to which he or she may be a party or in which he or she may become involved by reason of his or her being or having been a Director or Officer of BIZLIFE EDUCATION, or having served at BIZLIFE EDUCATION's request as a Director or Officer of any other corporation, whether or not he or she is a Director or Officer at the time such expenses are incurred, regardless of by whom the proceeding was brought, except in relation to matters as to which any such Director or Officer shall be adjudged liable for gross negligence or willful misconduct, provided that in the event of a settlement, the indemnification shall apply only when the Board of Directors of BIZLIFE EDUCATION approves such settlement and reimbursement as being for the best interest of BIZLIFE EDUCATION. The foregoing right of indemnification shall be in addition to, and not exclusive of, all other rights to which such Director or Officer shall be entitled.
- 10.2 Expenses of Lawsuits. Expenses incurred in defending a suit or proceeding whether civil, criminal, administrative or investigative, may be paid by BIZLIFE EDUCATION in advance of the final disposition of such action, suit or proceeding if authorized by all of the non-interested directors upon receipt of an undertaking by or on behalf of the Director or Officer to repay such amount if it shall ultimately be determined that he or she is not to be indemnified by BIZLIFE EDUCATION as authorized by these Articles of Incorporation.
- 10.3 <u>Insurance</u>. BIZLIFE EDUCATION shall have the authority to purchase, at its expense, and maintain insurance on behalf of any person who is or was a Director or Officer of BIZLIFE EDUCATION, against any liability asserted against him or her and incurred by him or her in any such capacity, or arising out of his or her status as such, whether or not BIZLIFE EDUCATION would have the power to indemnify him or her against such liability under the provisions of these Articles.

ARTICLE XI BYLAWS

The Bylaws of BIZLIFE EDUCATION shall be adopted by the Board of Directors and may be altered, amended or rescinded in the manner provided by the Bylaws.

ARTICLE XII AMENDMENTS

Amendments to these Articles of Incorporation shall be made in the following manner:

- 12.1 <u>Resolution</u>. The Board of Directors shall adopt a resolution setting forth the proposed amendment and directing that it be submitted to a vote at a meeting of the Board of Directors. This meeting may be either annual or a specially called meeting.
- 12.2 Notice. Within 30 days of the next meeting of the Board of Directors, or in any other manner provided for in BIZLIFE EDUCATION's Bylaws for the giving of notice of meetings of the Board of Directors, written notice setting forth the proposed amendment, or a summary of the changes to be effected thereby, shall be given to each Director, and each such Director shall be entitled to vote thereon. If the meeting is an annual meeting, the proposed amendment or such summary may be included in the notice of such annual meeting.
- 12.3 <u>Vote</u>. At such meeting, a vote of the Directors shall be taken on the proposed amendment. The proposed amendment shall be adopted upon receiving the affirmative vote greater than fifty percent of the Directors.
- 12.4 <u>Multiple Amendments</u>. Any number of amendments may be submitted to the Directors and voted upon by them at one meeting.
- 12.5 <u>Agreement</u>. If more than fifty percent of the Directors, as provided above, sign a written statement manifesting their intention that an amendment to these Articles be adopted, then the amendment shall thereby be adopted as through subsections 12.1 through 12.3 had been satisfied.
- 12.6 <u>Limitations</u>. No amendment shall make any changes in the qualifications for Directors or the voting rights of Directors without the unanimous approval in writing by all Directors.
- 12.7 <u>Filing</u>. A copy of each amendment shall be filed with the Secretary of State. State of Florida.

12.8 <u>Dissolution</u>. In the event BIZLIFE EDUCATION is dissolved, after paying or making provision for the payment of all of the liabilities of the Corporation, the assets of BIZLIFE EDUCATION shall be dedicated to a public body or conveyed to a non-profit organization within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law, with a purpose similar to that of BIZLIFE EDUCATION, as determined by the Board of Directors.
