

ARTICLES OF INCORPORATION

<u>OF</u>

THE CHURCH AT ODESSA, INC. (A Florida Not-for-Profit Corporation)

The undersigned hereby acknowledge and file with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a Not-for-Profit Corporation in accordance with the provisions of Chapter 617, Florida Statutes, as amended from time to time by the Legislature of the State of Florida, for the sole purpose of organizing a non-profit corporation and to that end do hereby set forth the following:

Article I

<u>Name</u>

The name of the Corporation shall be The Church at Odessa, Inc. (the "Corporation").

Article II

Address of Corporate Office

The street address of the principal office of the Corporation is 1234 Gunn Highway, Odessa, Florida 33556.

Article III

Purpose

The purpose of the Corporation is to function as a Christ-centered church and engage in all activities related thereto, in accordance with the Corporation's Constitution and Bylaws.

Article IV

Membership

The Corporation shall have members and the members of the Corporation will be required to meet the qualifications set forth in the Corporation's Constitution and Bylaws; provided however, neither the incorporator, agent, officers, nor the members of the Corporation shall have any vested right, interest or privilege of, in or to the assets of the Corporation, or any right, interest or privilege which may be inheritable or which shall continue once membership ceases in the Corporation.

Article V

Officers / Directors

Officers and directors shall be elected in the manner and for the term prescribed in the Corporation's Constitution and Bylaws.

Article VI

Distribution of Assets Upon Dissolution of Corporation

In the event of dissolution of this Corporation, the assets of the Corporation shall be distributed in accordance with provisions set forth in the Corporation's Constitution and Bylaws.
