ARTICLE ONE – NAME

The name of the corporation shall be: Shiloh All Family Empowerment, Inc.

ARTICLE THREE – PURPOSES

ARTICLES FIVE – EXISTENCE

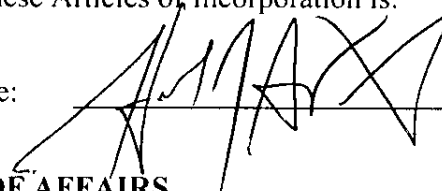

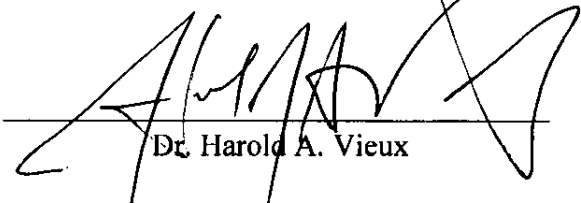
