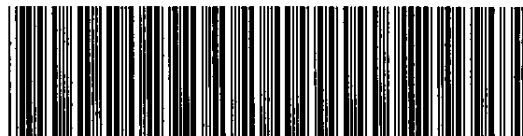

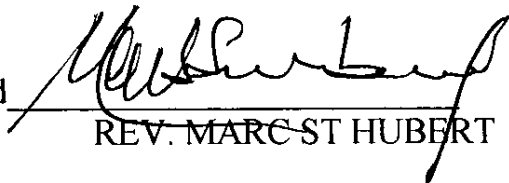

**ARTICLE OF INCORPORATION
OF
Emmaus International Alumni Association, Inc.**

The undersigned Incorporator, desiring to form a Corporation, (here-in referred to as the Organization) pursuant to the provision of the Florida Not For Profit Corporation Act, as amended (hereafter referred to as the "Act"), execute the following Articles of Incorporation.

ARTICLE I

Name

The name of the Organization shall be:

Emmaus International Alumni Association, Inc.

ARTICLE II

Duration and Dissolution

Section 1 - Duration

Founded on August 15, 2015, the duration of the Organization existence shall be perpetual until dissolution.

Section 2 - Dissolution

Upon the dissolution of the Organization, assets of the Organization shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV
Article of Faith

The article of Faith of the Organization is as follows: We believe

- 1) The full and unique inspiration of the Holy Bible as the divine Word of God, the only infallible, sufficient and authoritative rule of faith and practice.
- 2) One God, eternal existent in three persons: The Father, The Son and The Holy Spirit.
- 3) Deity of our Lord Jesus Christ, His virgin birth, His sinless life, His vicarious death, His bodily resurrection, His ascension, His intercession and his personal premillennial second coming in power and glory.
- 4) The fall of man, his moral depravity and the necessity of new birth.
- 5) Substitutionary atonement through the shed blood of Christ.
- 6) Justification by faith through regeneration by Holy Spirit.
- 7) Sanctification by faith (the in filling of the Spirit) subsequent to regeneration.
- 8) Security of the believer as he abides in vital fellowship with Christ.
- 9) Resurrection of the body unto eternal life.
- 10) Spiritual unity of all believers who comprise the church, the Body of Christ.
- 11) We believe in the physical rapture of the church to be in heaven with Jesus.
- 12) We believe in the biblical definition of marriage.

The articles of Faith may from time to time be amplified by the Board of Directors of the Organization.

ARTICLE V
Purpose and Power

Section 1 -Purpose

This Organization is organized exclusively for charitable, religious, educational, and scientific purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to Organizations that qualify as exempt Organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The purpose of this Organization is

uniting all former and current students and associates of Emmaus Vocational and Theological Seminary, in the same spirit and to accomplish the great commission of our faith through spiritual, physical and moral support to the members and their ministries. Our goal is to provide social and educational assistance to everyone within our resources specifically, but not limited to Haiti, Canada and the United States of America.

Section 2 - Power

The Organization shall have all lawful powers necessary or appropriate to conduct such business including, but not limited to, all corporate powers which Organizations may have under the Florida Not for Profit Organization Act.

Section 3 - Limitations

All of the purpose and powers on the Organization are subject to the express conditions and limitations that:

Item 1. No part of the net earnings of the Organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that Organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.

Item 2. No substantial part of the activities of the Organization shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the Organization shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Item 3. Notwithstanding any other provisions of this document, the Organization shall not carry on any other activities not permitted to be carried on by an Organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code, or by an Organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future tax code.

ARTICLE VI **Membership/Board of Directors**

Section 1 - Membership

This Organization shall have members. Anyone who is a former or current, student, faculty, staff or associate of Emmaus Vocational Bible School or its affiliate, can be a

member of the Organization. The eligibility, rights and obligations of the members will be determined from time to time by the Organization's Bylaws.

Section 2 – Board of Directors

The Board of Directors shall have complete and plenary power to manage, control and conduct all of the affairs of the Organization and shall have power to make, alter, amend and repeal the Bylaws of the Organization. No director shall have any right, title, or interest in or to any property of the Organization. The number of directors constituting the Board of Directors is five (5). Their Names, Title and Addresses are as follows:

Each member of the Board of Directors must be a member of the Organization and actively participate in the affairs of the Organization. The exact number of the members of the Board of Directors shall be specified from time to time by the Bylaws of the Organization, but the minimum shall not be less than three (3). Members of the Board of Directors shall serve until their successors are duly elected or until they are removed as provided in the Bylaws.

In the event of dissolution of the Organization, the assets which remain after discharge of all its liabilities, shall be distributed to not for profit Organizations which have qualified for the exemption under section 501C(3) and 590(a) (1)(2)(3) of the Internal Revenue Code of 1954, shall be distributed to not for profit Organizations which have qualified for the exemption under section 501C(3) and 590(a) (1)(2)(3) of the Internal Revenue Code of 1954 and whose purpose and objectives are similar to the Organization, such Organization(s) to be designated by a majority vote of the board.

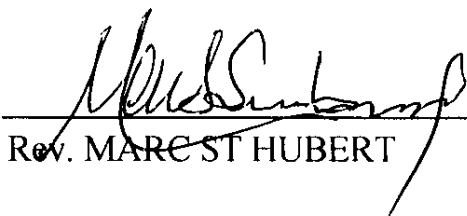
