ARTICLE VIII

Said organization is a ganized exclusively for charitable, educational and scientific purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future ederal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. As such assets not disposed of shall be be disposed of by a Cour of Competent Jurisdiction of the County in which the principal office of the corporation is the located, exclusively for such purposes or to such organizations as said court shall determine, which are organized and operated for such purposes.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustee, officers or other private persons, except that the corporation shall be authorized and empoyered to pay reasonable compensation for the services rendered and to make payments and d stributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be carrying on of propaganda, and the corporation shall not participate no intervene in (including the publishing or distribution of statements) any political campaign on tehalf of or in opposition to any candidate for public office.

Notwithstanding any o her provisions of these articles, the corporation shall not carry on any other activities not pen titted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the internal Revenue Code, or the corresponding section of any future federal tax code.
