**ADDING ADDITIONAL ARTICLES**

**ARTICLES IX: Corporate Purposes, Powers and Rights**

**MINISTERIO INTERNACIONAL DIOS ES AMOR.INC**

**Section 1.** The Corporation is organized and shall be operated exclusively for charitable, educational, religious, or scientific purposes, including as limited by such purposes, that it shall at all times be operated as an organization that is organized, and at all times operated exclusively for the benefit of, to perform the functions of, to support, or to carry out the charitable, educational, religious, or scientific purposes of the Beneficiary Organization, defined in article X below (provided such organization is an organization described in section 501(c)(3) or section 501(c)(6) and sections 509(a)(1) or (2) of the Code, at the time of any given distribution to or on behalf thereof), including providing contributions and other necessary resources to the Beneficiary Organization for the promotion of educational and vocational training opportunities.

Solely for the above purposes, the Corporation is empowered to exercise all rights and powers conferred by the laws of the State of Florida upon corporations not-for-profit.

**Section 2.** No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Directors, officers or private individuals, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article XI hereof. It is intended that this Corporation shall have and continue to have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended (hereafter, the "Code"), as an organization described in Section 501(c)(3) of the Code and which is other than a private foundation by reason of being described in Section 509(a)(1), (2) or (3) of the Code. These Articles shall be construed accordingly, and all powers and activities of the corporation shall be limited accordingly. The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to such extent as would result in the loss of its exemption from federal income tax under Section 501(c)(3) of the Code. No activity of the Corporation shall consist of participating in or intervening in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

**ADDING ADDITIONAL ARTICLES**

**ARTICLE X : Distribution of Assets Upon Dissolution**

**MINISTERIO INTERNACIONAL DIOS ES AMOR.INC**

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, distribute all of the assets of the Corporation exclusively for charitable, educational, religious, or scientific purposes to such qualified organization or organizations as the Board of Directors shall determine. An organization shall be deemed to be a "qualified" organization for purposes of this Article XI only if at the time of the distribution such assets it is organized and operated exclusively for the purposes described in Section 170(c)(2)(B) the Code and is described in Section 509(a)(1), (2) or (3) of the Code. Any of such assets not so distributed shall be distributed by the Circuit Court of the county in which the principal office of the Corporation is then located, exclusively for the aforesaid purposes of the Corporation or to such qualified organization or organizations as said court shall determine.

**ADDING ADDITIONAL ARTICLES**

**ARTICLE XI: Amendments**

These Articles of Incorporation may be amended by the affirmative vote of a majority of Directors present at a meeting of the Board of Directors at which a quorum is present; provided that notice of the meeting includes the proposed amendment or a summary of the changes.

**ARTICLE XII: Internal Revenue Code References**

All references in these Articles to sections of the Internal Revenue Code shall be considered references to the Internal Revenue Code of 1986, as from time to time amended, and to the corresponding provisions of any similar law subsequently enacted.



**ADDING ADDITIONAL ARTICLE**

**ARTICLE XIII: Immunity and Indemnification**

**MINISTERIO INTERNACIONAL DIOS ES AMOR.INC**

To the fullest extent permitted by the Not-For-Profit Corporation Law of the State of Florida, as the same exists or may hereafter be amended, a Director of the Corporation shall not be liable to the Corporation or its members, if any, for monetary damages in connection with the exercise of their duties as directors of the Corporation, and the Corporation's by laws may provide for indemnification of directors. Any repeal or modification of this Article shall not adversely affect any right or protection of any Director of the Corporation existing at the time of such repeal or amendment.

### **ARTICLE XIV: Statement of our Christian Faith.**

- 9.-We believe Jesus physically rose from the dead, was seen by His Disciples and Apostles. We believe Jesus has now ascended back into Heaven where He originally came from. Jesus is seated in Majesty, Power Authority.
- 10.-We believe that all human life is sacred and created by God in His image. We are to defend, protect, and value all human life (Salm 139). We only accept children for presentation to the Lord if their parent a members in good standing of our church and their Marriage is between a biological men and a biological woman.
- 11.- We believe our Statement of Christian Faith is under de principles of the sacrated scripture "The Holy Bible" , as the inspired and infallible Word of God that speaks concerning truth, morality, and the proper conduct of mankind.

## **ADDING ADDITIONAL ARTICLE**

### **ARTICLE XV : Statement of Christian Faith on Marriages, Gender Sexuality**

#### **MINISTERIO INTERNACIONAL DIOS ES AMOR. INC**

- 1.- We believe that God creates each person as male or female. These two distinct genders together, reflect the image of God (Genesis 1:26-27).
- 2.-We believe that the marriage has only one meaning: the uniting of one biological man and one biological woman in a single, exclusive union, as delineated in Scripture (Genesis 2:18. We believe that God Intends sexual intimacy to occur only between a biological man and a biological woman who are married to each other. (1Corinthians 6:18 7:2-5 - Hebrews 13:4)
- 3.- We believe that any form of sexual immorality, adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and use of pornography, is sinful and offensive to God. (Matthew 15:18-20 - 1 Corinthians 6:9-10).
- 4.-We believe that in order to preserve the function and integrity of our Church as the Body of Christ, we and to provide a biblical role model to our members and the community, it is imperative that all persons employed by our church in any capacity, or who serve as volunteers, agree to and abide by this Statement of Faith on Marriage, Gender and Sexuality. (Matthew 5:16; Philippians 2:14-16 - 1 Thessalonians 5:22).
- 5.-We believe that God is merciful to all sinners. He offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ (Acts 3:19-21; Romans 10:9-10 and 1 Corinthians 6:9-11).
- 6.- We believe that every person must be offered compassion, love, kindness, respect, and dignity (Mark 12:28-31 - Luke 6:31). Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the doctrines of our Church.
- 7.- We believe that God has ordained marriage and defined it as the covenant relationship between a man and a woman, and Himself, our church only recognizes marriages between a biological man and a biological woman.
- 8.- We believe that the senior pastor, ministers, staff and volunteer of our church shall only participate in weddings and solemnize marriages between one biological man and one biological woman that are active members in good standing of our Church. In addition, we believe they shall only participate in children presentations, funer ceremonies, birthday celebrations and other activities involving relationships between on biological man and a biological woman.
- 9.-We believe that the facilities and properties of our church shall only host weddings between a biological man and a biological woman.

**ADDING ADDITIONAL ARTICLE**

**ARTICLE XVI: Statement of Church Membership Policy**

**MINISTERIO INTERNACIONAL DIOS ES AMOR. INC.**

- 1.- We believe that membership of our church be composed only individuals who are believers in the Lord Jesus and affirm the tenets of the Church Statement of Faith and the church's Statement of Faith on Marriage, Gender and Sexuality.
- 2.- We believe that all members should offer evidence, by their confession and their conduct, that they are living in accordance to the rule of faith and conduct of the Holy Bible and our Church's Statement of Faith.
- 3.- We believe that to c to preserve the function and integrity of the church as the local Body of Christ, and to provide a biblical role model to the church members and the community, it is imperative that all persons who associate with the church as members should abide by and agree to the church's statement of membership policy.
- 4.- We believe discipline will follow the biblical pattern is an effort to bring the individual to repentance and protect the church from unrepentant sin. Discipline may involve exclusion from participation in ministerial privileges and activities.
- 5.- We believe that in order for an individual to apply for membership should have been attending regularly for at least (6) months our weekly services and have been attending discipleship classes and must have a conduct according to the Holy Bible and the Church's Statement of Faith.
- 6.- The Corporation shall have no voting members.

**ADDING ADDITIONAL ARTICLE ADDING**

**ARTICLE XVII :Statement of Religious Employment**

- 1.-We affirm and project that all religious activity out or inside of the Church is based en la discipline of the Holy Bible.
- 2.-We believe that every position within the church, employees and volunteers, furthers the church's religious mission and has to be filled by a person that his/her life is inspired and reflect the doctrine of faith and conduct according to the Holy Bible and the church's Statement of Faith.
- 3.- We believe every employee and volunteer of the church has to agree, support and lives according to the Church Statement of Faith.
- 4.- We believe that the Ministerial Exception is a legal doctrine that clearly state that churches are exempt from anti-discrimination laws in hiring and firing employees.

**ADDING ADDITIONAL ARTICLE**

**ARTICLE XVIII: Statement on Church Facility Use Policy**

**MINISTERIO INTERNACIONAL DIOS ES AMOR, INC.**

- 1.- We believe that the church's facilities use would not be permitted to persons or group holding, advancing, or advocating beliefs or practices that conflict with the church's statement of faith or moral teaching that are summarized in the Articles of Incorporation
- 2.- We believe that, in no event shall persons or groups who hold, advance, or advocate beliefs, or advance, advocate, or engage in practices that contradict the church's faith use any church facility. The church's facilities should not be used in any way that contradicts the church's statement of faith.
- 3.- We believe that this policy applies to all church facilities, regardless of whether the facilities are connected to the church's sanctuary or are not, because the church sees all of its property, present and future, as holy and set apart only to worship God. (Colossians 3:17).
