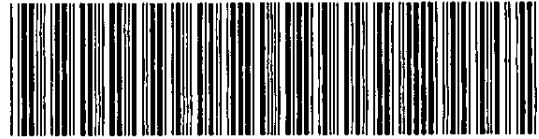

This permanent Amendment to The Articles of Incorporation of Maritime Line Association Inc., a corporation organized under the laws of the State of Florida, is made on April 20, 2016.



Article 2 of the above-referenced Articles of Incorporation is hereby amended in its references to the Federal Maritime Commission and Internal Revenue Code to read as follows:

"The purpose of this Corporation shall be, as a Shippers' Association in accordance with the regulations of the U.S. Federal Maritime Commission and the Shipping Act of 1984 et. seq. governing these matters, to cultivate closer relations between members engaged in the business of Non-Vessel Operating Common Carriers ("NVOCCs"), to promote their joint interests, provide for their mutual protection, to maintain the ethics of the profession at their highest standard, to discuss and interchange ideas concerning traffic matters, and by publicity, conference, and other proper means to promote the general interests of the trade including by consolidating or distributing freight on a nonprofit basis for the members of the group via carload, truckload, or other volume rates or service contracts.

The Corporation is organized and the purpose of the Corporation is to engage in exempt function activities as described in Section 501(c) (6) of the Internal Revenue Code of the United States, which activities are exempt from taxation under such section. No part of the Corporation's earnings shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the Corporation is authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purpose. It is not organized for profit and no part of the net earnings shall inure to the benefit of any private shareholder or individual."

All other portions of the Articles of Incorporation dated April 20, 2016 remain in full force and effect.
