- IX. ARTICLE OF MARRIAGE AND SEXUALITY
- a. WE BELIEVE IN THE BIBLICAL TEACHING THAT MARRIAGE IS BETWEEN ONE MAN AND ONE WOMAN. MARRIAGE OUTSIDE OF THOSE PARAMETERS WILL NOT BE PERFORMED BY CHURCH MINISTERS OR ON CHURCH PROPERTY.
  - b. WE DO NOT PERFORM MARRIAGES FOR TRANSGENDERS, HOMOSEXUALS, LESBIANS, QUEERS, BISEXUALS, GAY MEN AND GAY WOMEN.
  - c. HOMOSEXUALS, GAY MEN AND GAY WOMEN WILL NOT BE ALLOWED TO CONDUCT CHURCH SERVICES SUCH AS TEACHING, PREACHING OR HOLDING AN OFFICE WITHIN THE CHURCH. THEY ARE VERY WELCOME TO ATTEND CHURCH SERVICES.
- X. BIBLICAL AUTHORITY
- a. THIS CHURCH ACCEPTS THE BIBLE AS THE REVEALED WILL OF GOD, THE ALL-SUFFICIENT RULE OF FAITH AND PRACTICE AND FOR THE PURPOSE OF FULFILLING GOD'S MISSION.
  - b. TO COLLECT AND DISBURSE ANY AND ALL NECESSARY FUNDS FOR THE MAINTENANCE OF SAID CHURCH AND THE ACCOMPLISHMENT OF ITS PURPOSE.
  - c. TO DEVOTE THE SAME TO FOREGOING PURPOSES OF THE CHURCH; AND TO DO ANY AND ALL LAWFUL ACTS AND THINGS WHICH MAY BE NECESSARY, USEFUL, SUITABLE OR PROPER FOR THE FURTHERANCE OF THE ACCOMPLISHMENT OF THE PURPOSE OF THIS CHURCH. PROVIDED NO ACT MAY BE PERFORMED WHICH WOULD VIOLATE SECTION 501 (C) (3).
- XI. STATEMENT OF PURPOSE
- a. THE FACILITIES WILL NOT BE USED FOR ACTIVITIES THAT CONTRADICT, OR ARE DEEMED BY THE PASTOR AS INCONSISTENT WITH OR CONTRARY TO THE CHURCH'S FAITH OR MORAL TEACHINGS. THE PASTOR, OR HIS OFFICIAL DESIGNEE, IS THE FINAL DECISION-MAKER ON WHETHER A PERSON OR GROUP IS ALLOWED TO USE CHURCH FACILITIES.
- XII. SENIOR PASTOR-PRESIDENT
- a. SENIOR PASTOR SHALL BE THE PRESIDENT OF THE CHURCH AND SHALL BE IN CHARGE OF ALL THE MINISTRIES OF THE CHURCH.
- XIII. AMENDMENTS TO BYLAWS
- a. THESE BYLAWS MAY ONLY BE ALTERED, AMENDED OR REPEALED AND NEW BYLAWS MAY ONLY BE ADOPTED BY SENIOR PASTOR, VICE PASTOR AND CHURCH CLERK.
