ARTICLES OF INCORPORATION

OF

THE MIND, BODY & SOUL SURFING CLUB'S RECOVERY FOUNDATION, INC.

(A Corporation Not For Profit)

Pursuant to the requirements of the Florida Not For Profit Corporation Act (the "Act"), the undersigned does hereby make, swear to, adopt and file these Articles of Incorporation of The Mind, Body & Soul Surfing Club's Recovery Foundation, Inc. (the "Corporation").

ARTICLE I Name and Duration

The name of the Corporation is The Mind, Body & Soul Surfing Club's Recovery Foundation, Inc. The term of duration of the Corporation shall be perpetual.

<u>ARTICLE II</u> <u>Principal Office and Mailing Address</u>

The address of the principal office and the mailing address of the Corporation is 4853 S. Orange Avenue, Suite B, Orlando, Florida 32806.

ARTICLE III Registered Office and Agent

The street address of the registered office of the Corporation is at 2914 Carmia Drive, Orlando, Florida 32806, and the name of the registered agent at the address is John W. Foster.

<u>ARTICLE IV</u> Corporate Purposes, Powers and Rights

Section 1. The Corporation is organized and shall be operated exclusively for charitable, scientific and educational purposes as defined in Section 501(c)(3) of the Code. In furtherance thereof, but without limitation thereon, the Corporation shall hold, invest and administer assets

received as charitable gifts, bequests and contributions and use such assets or the income therefrom as follows:

(1) to make grants and other distributions to (i) conduct charitable activities and projects and (ii) support activities and projects conducted by organizations operated exclusively for charitable purposes; and

(2) to acquire or receive from any person, firm, association, corporation, trust or foundation by deed, gift, purchase, bequest, devise or otherwise, cash, securities, or other property, real and personal, and to hold, administer, manage, invest, reinvest, and disburse the principal thereof and/or the income therefrom solely for the purposes stated in these Articles of Incorporation.

Solely for the above purposes, the Corporation is empowered to exercise all rights and powers conferred by the laws of the State of Florida upon corporations not for profit.

Section 2. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, Directors, officers or private individuals, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Section 1 of this Article. It is intended that this Corporation shall have and continue to have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code. These Articles of Incorporation shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly. The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to such extent as would result in the loss of its exemption from federal income tax under Section 501(c)(3) of the Code. No activity of the Corporation shall consist of participating in or intervening in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE V Members

The Bylaws of the Corporation may make provision with regard to members of the Corporation, including the manner of admission to membership.

ARTICLE VI Directors

Directors shall be elected, appointed and removed as provided in the Bylaws of the Corporation, as the same may be amended, restated or otherwise modified from time to time.

ARTICLE VII Incorporator

<u>ARTICLE VIII</u> <u>Distribution of Assets Upon Dissolution</u>

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, distribute all of the assets of the Corporation exclusively for charitable, scientific or educational purposes to such "qualified" organization or organizations pursuant to a plan of distribution voted on and adopted by the members. An organization shall be deemed to be a "qualified" organization for purposes of this Article VIII only if at the time of the distribution of such assets it is organized and operated exclusively for the purposes described in Section 170(c)(2)(B) of the Code and is described in Section 501(c)(3) of the Code. Any of such assets not so distributed shall be

distributed by the Circuit Court of the county in which the principal office of the Corporation is then located, exclusively for the aforesaid purposes of the Corporation or to such qualified organization or organizations as said court shall determine.

ARTICLE IX Amendments

These Articles of Incorporation may be amended only as provided in the Bylaws of the Corporation.

<u>ARTICLE X</u> Code References

All references in these Articles is sections of the "Code" shall be considered references to the Internal Revenue Code of 1986, as from time to time amended, and to the corresponding provisions of any similar law subsequently enacted.

ARTICLE XI Indemnification

The Corporation shall fully indennify any officer, director, employee or agent or any former officer, director, employee or agent to the fullest extent permitted by law.
