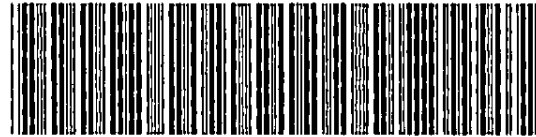




Dear Lawrence:
