

#### Dear BACRAP Board Members:

Please accept my Letter of Resignation from Broadmoor Acres Community Restoration and Preservation Inc and the position of Executive Director. Unless this Board wishes to make my resignation effective sooner, my resignation will become effective on Midnight January 1, 2020.

As to my position as CEO of BACRAP, that position will continue to be held until this Board chooses to make a motion and vote on termination of this position.

While I am very proud of what I and this Board have accomplished in the Broadmoor Acres Community of Cocoa from early 2015 to date; I also believe that the ability for this organization to move forward hinges on my removing myself from it. The decision to leave is not one made without careful consideration, but it is the right one to make.

As was relayed to Chairman Harvey, I am removing myself from BACRAP for the best interest of BACRAP and the residents of the Broadmoor Acres Community. For this to succeed BACRAP needs to take on the roll of fund raising and hiring without my always being the one to

Nor can I be a party to asking a City Council whose head I am currently seeking removal of for not being legally holding of that office, to agree to any agreement between BACRAP and the City of Cocoa.

In a conversation with Bob last week I explained that while I am resigning and removing myself from BACRAP, I will when asked by you assist in the building and planning and overseeing of future construction should that be requested. I have faith in the Board of Directors continuing this mission and bringing its goal to the finish line.
