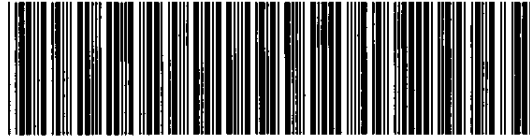

The mission and purpose of the Wakulla Commercial Fishermen's Cooperative, Inc. is to establish a non-profit corporation democratically operated by members of the Wakulla County commercial fishing industry in order to lower commercial fishing operational costs, which are economically crippling for individual fishermen; effectively market commercial fishing products; reduce aquatic environmental waste, notably from fish-kill in regulated nets; develop value-added products; provide useful data for government management of future fish populations, create job opportunities for the community and revitalize the commercial fishing heritage of the county

Directors must be voting members of the corporation and shall be bonded in such amounts and by such surety as the Board may require.
