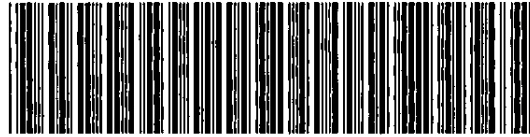

**Added Purposed Clause and Dissolution of Assets Provision**


The founding members of the Afro-American Historical and Genealogical Society East Central Florida Chapter, Inc., all of whom are citizens of the United States, desire to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

- (1) The organization is organized and operate exclusively for charitable and educational purposes as set forth within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- (2) Upon the dissolution of the corporation, the Chapter president shall send a letter by certified mail, registered receipt requested, to the national Afro-American Historical and Genealogical Society, Inc. (AAHGS) Board of Directors, with a copy to the national Chapters Committee advising of the need to dissolve the chapter. The Board of Directors shall request the chapter's assets, along with the chapter's files, be forward to the national organization of AAHGS, who will distribute the assets for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
