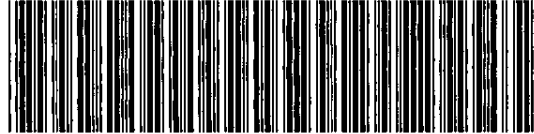

We the undersigned, all of whom are of legal age, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit, under the following proposed charter.

Article I
Name of Corporation

The Name of this Corporation shall be, ***The Florida Treasure Coast Baptist Association, Inc.*** (hereinafter "Association") This corporation shall have perpetual existence unless it is dissolved by the laws of the State of Florida or by voluntary dissolution by a two- thirds majority vote of its officers. Upon its dissolution, no part of its assets shall inure to the benefit of any private individual or organization. In the event of dissolution, assets shall inure to tax exempt religious organizations of like genre.

Article II
The Principle Place of Business

The Principle place of business is located at 812 North 7th Street, Fort Pierce, Florida 34950

Article III
Purpose

This corporation shall at all times be operated for religious and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

The purpose of this association shall be to establish an ecclesiastical (Church) entity to facilitate the following:

1. Communication and Fellowship among Baptist Churches and Christian Churches that proclaim and adhere to the *Articles of Faith*.
2. Devise methods and strategies for the furtherance of the Christian causes.
3. Christian Education
4. Missions that address ongoing needs and emergency needs at home and abroad.
5. To serve as an umbrella for necessary Auxiliaries and standing committees that are concomitant to the work of the Association.

Membership

Membership is open to all Baptist Churches and Christian Churches who subscribe to the *Articles of Faith*. Churches and Ministers shall be admitted by application and/or recommendation from a connected party.

Article IV

Manner in which Directors are Appointed

The Directors of the Association shall consist of the Moderator (CEO), Vice Moderator (VP), Secretary, Treasurer and others appointed by the Moderator. These officers shall be ratified as per the Constitution and Bylaws of the Association.

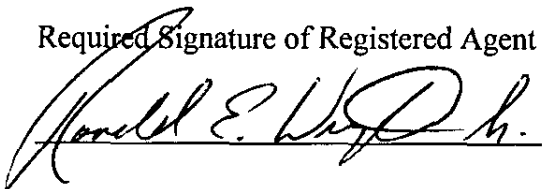

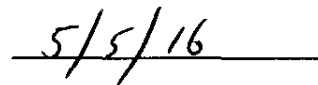

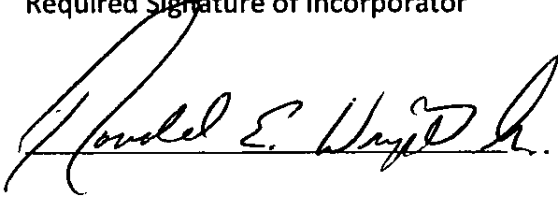
