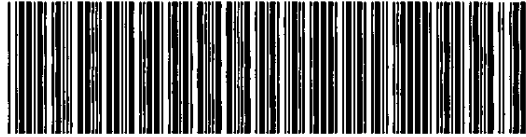

ARTICLE I **NAME**

The name of the corporation shall be: Mesoras Avraham Inc.

ARTICLE III **PURPOSE**

The purpose for which the corporation is organized is:

Mesoras Avraham is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Specifically, Mesoras Avraham is a charitable religious organization created to serve the needs of those mourning the loss of a loved one by providing the necessary goods and services associated with Jewish mourning practices.

ARTICLE IV **DISSOLUTION OF ASSETS PROVISION**

The plan upon the dissolution of the organization is:

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.




