

The Corporation shall be dissolved according to the procedures outlined in the Florida Nonprofit Corporation Act.

After the liabilities of the Corporation have been discharged or provided for, the Corporation's remaining assets shall be disposed of to facilitate one or more of the exempt purposes of the Corporation. Assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or shall be distributed to the federal government, or a state or local government, for public purposes. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal off of the Corporation is then located, exclusively for such purposes or to such organization or organizations which are organized and operated for such purposes.
