Said organization is organized exclusively for charitable, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization, as said Court shall determine.

2. To distribute funds between non-profit organization through proposals justifying the use of those funds.

3. To provide with Scholarships to low-income students, grants will be awarded for Civic and Social Entities and Treatment Centers with therapeutic and mental health models.

4. To provide financial aid to individuals that even though receive some income, is not sufficient for the purpose of finishing a higher education or a technical training.

5. Similarly, to provide hospitals means to apply for funding for the benefit of physical health and those opportunistic diseases such as HIV / AIDS, addiction, alcoholism, tobacco or those other transmitted diseases that require appropriate treatment for the improvement of health.
