ARTICLES OF INCORPORATION OF

Citizens for a Better Tomorrow, In SECRETARY OF STATE

A Florida "Not for Profit" Corporation

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

- NAME OF CORPORATION: The name of the corporation is Citizens for a Better Tomorrow, Inc. A.
- B. PRINCIPAL OFFICE: The principal office of the corporation is located at 490 Opa-locka Blvd #20 Opalocka FL, 33054
- MAILING ADDRESS: The mailing address of the corporation is 490 Opa-locka Blvd #20 Opa-locka FL, C. 33054
- D. **REGISTERED AGENT:** The name of the registered agent of the corporation is John Little. The address of this registered agent is 963 NE 153 St., Miami, FL 33162
- E. DURATION/MEMBERSHIP: The period of duration is perpetual. The qualification for members, if any, and the manner of their admission shall be regulated by the bylaws.
- BOARD OF DIRECTORS: The method of selection of the Board of Directors and number of directors F. shall be stated in the bylaws.
- INCORPORATOR: The name and address of the incorporator is: Willie Logan, 490 Opa-locka Blvd #20 G. Opa-locka FL, 33054.
- CORPORATE PURPOSES: This corporation is not organized for profit but exclusively for the promotion of social welfare. The foregoing purposes shall be exercised exclusively in such a manner that the Corporation will qualify as an exempt organization under section 501(c)(4) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- NO PRIVATE INUREMENT: The Corporation is not organized nor shall it be operated for the primary purpose of generating pecuniary gain or profit. The Corporation shall not distribute any gains, profits or dividends to the Directors, Officers, or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the Corporation's exempt purposes. The property, assets, profits and net income of the Corporation are irrevocably dedicated to exempt purposes no

part of which shall inure to the benefit of any individual.

H. **DISSOLUTION:** Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.
