authority in all matters pertaining to Ethics, Spirituality and Religious Law. This synagogue shall be empowered
to contract, rent, buy or sell personal or real property, in order to provide a place of worship as well as a parsonage for the

Jewish communal life. It shall be empowered to ordain those who have shown the proper spiritual gifts. This
