**ARTICLES OF INCORPORATION
OF
INTERNATIONAL CHURCH PLANTING MINISTRY INC.**

The undersigned, being natural person over eighteen years of age acting as an incorporator pursuant to Chapter 617, Article 1396-3.02 of the Florida Non Profit Corporation Act, adopt the following Articles of Incorporation of such Corporation.

ARTICLE I

The name of the corporation is INTERNATIONAL CHURCH PLANTING MINISTRY INC.

ARTICLE II

The corporation is Non-Profit Corporation.

ARTICLE III

The period of duration of the corporation is perpetual unless dissolved according to the law. Corporation existence shall commence upon the 20th of May 2016.

ARTICLE IV

The principal place of business shall be 9804 N 26th Street, Tampa, FL 33612

ARTICLE V

GENGERAL AND SPECIFIC PURPOSES

The specific and primary purposes for this Non-Profit Corporation are formed as follows:

- (a) To plant, establish, and maintain church environment and to provide a place of worship for it.
- (b) To establish, maintain, and conduct schools for religious instructions. And to further religious, educational, and charitable work. To that end adopt and establish Bylaws, and make rules and regulations deemed necessary and expedient for management of this affairs, in accordance with law, and not inconsistent with this Articles of Incorporation.
- (c) To take, manage, hold, and dispose of the property, and real estate of said corporation.
- (d) For religious, educational, moral instructions, and lectures;
- (e) The generating of missionary powers through religious area for the furtherance of its primary purpose, and to conduct services of religious nature and moral character.
- (f) To operate exclusively in any other manner for such religious, educational, and charitable purposes as will qualify it as an Exempt Organization under Section 501©3 of the Internal Revenue Code of 1954 as amended or under any corresponding provisions of any subsequent Federal Taxes Laws covering the distributions to organizations qualify as Tax-Exempt organizations under the Internal Revenue Code.

ARTICLE VI

The corporation shall have members. The qualifications for members and manners for their admission are general, no specific qualifications and as set forth in the corporation Bylaws.

ARTICLE VII

The affairs of the corporation shall be managed by the Board of Directors. The number of Directors constituting of the initial Board of Directors is three. The names and the address of the persons serving on the initial Board of Directors are as follows (not less than three):

ARTICLE IX

EARNINGS AND ACTIVITIES OF THE CORPOATION

- (a) No part of the earnings of this corporation shall incur to the benefit of, or be distributable to its members, Trustees, officers, or any other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purpose set in this Articles of Incorporation.
- (b) No substantial part of the activities of the corporation shall be carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intercede in (including the publishing or distribution of statement(s) in any political campaign on behalf of any candifate for public office.
- (c) Notwithstanding any other provision of these Articles , the corporation shall not carry on any other activities not permitted to be carried out by a corporation exempt from Federal Income Tax under Section 501©3 of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Code), in which are deductible under Section 170 ©(2) of the Internal Revenue Code of 1954 or any corresponding provisions of any United States Revenue Law.
- (d) Notwithstanding any other provisions of these Articles this corporation shall not accept to an insubstantial degree , engage in any activities or exercise any powers that are not in furtherance of the purpose of the corporation.

ARTICLE X

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for paying of all liabilities of the corporation, transfer all assets to a fund, foundation, or organization which is organized and operated exclusively for charitable, educational, or religious purposes and shall at the time qualify as an organization exempt from Federal Income Tax under Section 501©3 of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE XI

The street address and city of the initial registered office of the corporation is 9804 N 26th Street, Tampa, Florida 33612. And the name of the Registered Agent located at such address is Esther Oluokun .


