(b) by a corporation contributions which are to be deductable under section 170(c) (2) of the Internal revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law Tax Code including the following specific purposes:

- 1. To proclaim the Gospel of the Kingdom of Jesus Christ
- 2. To assist in and out of its surrounding communities in carrying out the commission of Jesus Christ (Matthew 28:18-20)
- 3. To encourage the Body of Christ on Earth as we preach Thy Kingdom Come O Lord Thy Will be done on Earth as it is in Heaven.
- 4. To accept Matthew (19:4-5)
- 5. In Order to accomplishment the above mentioned purpose The Corporation shall have the following Powers:
  - a) To accept, acquire, receive, take and hold by bequest, devise, grant, gift, purchase, exchange, lease, transfer, judicial order or decree, or otherwise, for any of it objects and purposes, any property, both real and personal, of whatever kind, nature of description and wherever situated.
  - b) To sell, exchange, convey, mortgage lease transfer or otherwise dispose of the Corporation may require, subject to such limitations as may be prescribe by law

- 4. To accept Matthew (19:4-5)
