## **ARTICLES OF INCORPORATION**

In compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE VIII**

Said organization is organized exclusively for educational, training and community service purposes only.

### **ARTICLE IX**

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be clause hereto. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c)(3) or the Internal Revenue Code, or corresponding section of any future 170 (c)(2) of Internal Revenue Code, or corresponding section of any future federal tax code.

### **ARTICLE IX**

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organize and operated exclusively for such purposes.
