Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida not-for-profit corporation adopts the following amendment to its Articles of Incorporation.

History and Corporate Status

A. The original Articles of Incorporation (the "Articles") of Roots and Wings Inc. ("R&W") were filed on June 7, 2016.

B. R&W does not have members.

C. The Board of Directors of R&W, at a meeting duly called and held on April 24, 2023, by a unanimous vote of the entire Board then in office, adopted the amendment to paragraph (d) of Article IX of the Articles set forth below (the "Amendment") in accordance with Sections 617,1002 and 617,1007 of the Florida Statutes.

D. Because R&W does not have members, the only action required to approve the Amendment was the approval of the Board referred to in Paragraph C above.

Amendment to Paragraph (d) of Article IX

Paragraph (d) of Article IX is amended to read in its entirety as follows:"

"(d) The officers of the Corporation (hereinafter referred to as the "Officers") and their respective responsibilities shall be as set forth in the By-Laws. All Officers shall serve at the pleasure of the Board. The initial Officers shall be the individuals named in Article X below."
