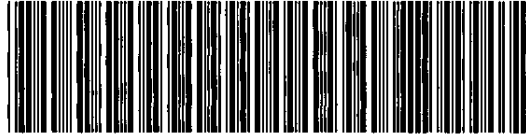



This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes. The specific purpose of this corporation is: Educational programs in the financial management and management accounting fields, namely, arranging and conducting educational conferences, educational demonstrations and educational testing.

Association services, namely, promoting the interests of management accountants; promoting public awareness of the need for management accountants and of the need for educational programs in the fields of management accounting and financial management; research in the field of management accounting.

This corporation is organized and operated exclusively for charitable purposes. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof or to the benefit of any private person.
