

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I : NAME

The name of this corporation shall be: Kingdom Authority Network, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal street address is: 4428 Mt. Pleasant Road, Quincy, Florida 32352 The mailing address is: 4428 Mt. Pleasant Road, Quincy, Florida 32352. The principal office shall be located in Gadsden County, Florida.

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is: charitable, educational, and religious. To provide prevention, intervention, educational, and faith-based (Christian) services to children, youth, families, and other individuals, including all activities that is lawful in the State of Florida and the United States of America and including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: MANNER OF ELECTION

The manner in which directors are elected and appointed: The number of directors shall be no less than three or no fewer than required by law. The directors shall be elected at the annual meeting of by a majority of the membership and each director shall be elected to serve until his successor shall be elected and qualify. The Board of Directors shall consist of individuals who support the mission and the philosophy of the corporation and are willing to actively contribute to the advancement of its mission. Any director may resign at any time. Such resignation shall be made in writing, and shall take effect at the time specified therein, if no time is specified, at the time of receipt by the President. The acceptance of a resignation shall not be necessary to make it effective. If the office of any director becomes vacant, though less than a quorum by a majority vote, the remaining directors may appoint any qualified person to fill such a vacancy, and to hold office for the unexpired term and until his successor shall be duly chosen. Any director or directors may be removed at any time with or without cause by the affirmative vote of the majority of its board.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any

activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE V: INTIAL DIRECTORS AND/OR OFFICERS

The officers shall consist of a President (1); Chairman (1); Vice Chairman (1); Secretary (1); Treasurer (1); and other official positions as deemed necessary by the Board of Directors. The officers, with the exception of President, shall serve for a three (3) year term, or until a successor is elected. If a vacancy occurs in any office for any reason whatsoever, such vacancy shall be filled by the Board of Directors. The officers, with the exception of the president, shall be elected every three years at the first meeting of the Board of Directors of the new year.
