# **ARTICLES OF INCORPORATION**

**ARTICLE I: NAME** 

SECRETARY OF STATE

The name of the Corporation shall be CHILDREN 4 A GOOD CAUSE FOUNDATION, INCA SHIFTITHEIRIDA references to the Corporation within this document are noted as the "Foundation."

## **ARTICLE II: PRINCIPAL OFFICE**

The place in this state where the principal office of the Foundation is to be located is the 7926 Picklewood Park Drive, Boynton Beach, FL 33437.

### **ARTICLE III: PURPOSE**

The Foundation is organized exclusively for charitable, educational, and/or scientific purposes, including, for such purposes, providing distributions to organizations that qualify as exempt organizations within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IV: MANNER OF ELECTION**

The manner in which the directors are elected shall be by a majority vote of directors present at a regular or special meeting of the Board convened for that purpose.

#### **ARTICLE V: INITIAL DIRECTORS**

The number of initial Board of Directors shall be three (3). All decisions regarding the Foundation will be decided upon by majority rule amongst the Board. The names and addresses of the persons who are the initial Directors of the Foundation are as follows:

#### **ARTICLE VI: LIMITATIONS**

No part of the net earnings of the Foundation shall inure to the benefit of, or be distributable to its members, directors, or other private persons, except that the Foundation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Purpose hereof.

No substantial part of the activities of the Foundation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Foundation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

The corporation will not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, the Foundation shall not carry on any other activity not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or by a corporation, contributions.

#### **ARTICLE VII: DEDICATION OF ASSETS**

The Foundation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Foundation will not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The Foundation will not make any investments in a manner as to subject it to tax under Section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Foundation will not make any taxable expenditures as defined in Section 4945 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this Foundation, any remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE VIII: PERSONAL LIABILITY**

No officer or director of this Foundation shall be personally liable for the debts or obligations of the Foundation of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of debts or obligations of this Foundation.
