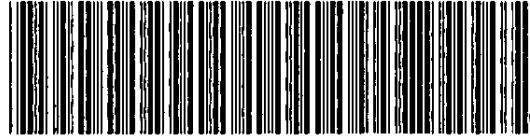

Article I

The name of the corporation shall be 16 Green Acres Farm.

Article II Duration

The period of duration of 16 Green Acres Farm is perpetual unless dissolved.

Article III Purpose

16 Green Acres is a non-profit corporation and shall operate exclusively for educational and charitable purpose within the meaning of section 501 (c)(3) of the Internal Revenue Code or the corresponding section of any future Federal Tax Code.

16 Green Acres is a teaching farm for school-aged children. The farm will give people an opportunity to observe nature, introspect and reflect upon our lifestyles and our role in this natural world.

The farm will allow school-aged children to interact with farm animals, plants and understand and learn how farming keeps the universe working.

16 Green Acres will follow the Florida Standards/Common Core Curriculum for school-aged children. The farm, will allow school systems to bring students to the farm for hands on experiences with animals and plants. It is a great place for outdoor activities to get city kids away from TV and video games and to bring them closer to nature that is surrounded by wilderness, trees, birds, insects, and

the Florida wildlife. For those who fear insects and the outdoors, it is just a condition of the brain and 16 Green Acres will help them overcome that fear.

16 Green Acres will have:

- Shelter for Emergency Animals
- Shelter for Emergency Child Care
- Shelter for Emergency Teenage Care

16 Green Acres will be organized as a charitable, religious, educational, literary, and scientific purpose.

16 Green Acres Definition

16 Green Acres is a small diversified farm – a small scale operation that grows a variety of animals and crops, where people came to pet the animals, pick the crops and learn the workings of a farm. “Still other seeds fell on good soil, it came up, grew and produced crops, some multiplying thirty, some sixty, some a hundred times”*


