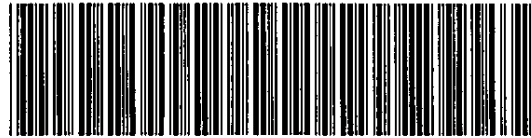

Amend Article III: To provide a dance environment in South Florida for the public to learn and preserve historical American Jazz dances such as East Coast Swing, Lindy Hop, Chareleston, Balboa, and Blues. The organization is organized exclusively for charitable, and educational purposes under section 501(c)(3) of the Internal Revenue Code , or corresponding section of any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in section 501(c)(3).

Add Article IX : Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
