



Pursuant to the provisions of section 617.1002 and 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

MANNER OF ADOPTION:

There are no members or members entitled to vote on the amendment. These Articles of Amendment were adopted by the board of directors of said organization at a regular meeting with a quorum being present which was held on SEP, SI, SI, SI. This meeting of the directors met the requirements of both the Articles of Incorporation and the bylaws.

THE AMENDMENT

The Articles of Incorporation of the ULGM Covenant Palms Inc are hereby amended as follows:

1. Article III of the Articles of Incorporation is hereby replaced. The new Article III reads as follows:

Article III Corporate Purposes

- A. This corporation is formed exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Included within those purposes is the fostering of housing for low income persons.
- B. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
- D. All of the foregoing purposes shall be exercised exclusively charitable in such a manner that the Corporation will qualify as a exempt organization described in section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
