#### Article I. Corporate Name

#### Article II. Terms of Existence

This Corporation shall have perpetual Existence.

#### Article III. Purpose and Powers

Said Corporation is organized exclusively for charitable, religious, scientific, and educational purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code. To develop as a Church under traditional Christian idealism, following the teachings of the Holy Bible and of Jesus Christ. To perform regular and normal Sunday Services, Sunday School services, Bible Study, Communion, Baptism, Revivals, Anniversaries and other celebratory services, to network with other churches.
