



# ARTICLES OF INCORPORATION

#### OF A. PHILIP RANDOLPH INSTITUTE of

#### FLORIDA, INC.



The undersigned subscribe to these Articles of Incorporation pursuant to the provisions of Chapter 617, Florida Statutes, for the purpose of forming a corporation not for profit and further state as follows:

#### ARTICLE I

# Name and Principal Place of Business

The name of the corporation is the A. Philip Randolph Institute of Florida, Inc. is a state chapter of the national A. Philip Randolph Institute, headquartered in Washington, DC. Founded in 1965 by A. Philip Randolph (1889-1979), President and Bayard Rustin (1912-1987).

#### **ARTICLE II**

# Principal place of Business

The initial principal place of business is: 2220 Edgewater Dr, Orlando, Florida 32804. Our mailing address is APRI of Florida, PO Box 568701, Orlando, FL 32856-8701.

#### ARTICLE III

#### **Purpose**

APRI is an education and charity organization for civil rights, economic & social justice issues affecting black communities. Primarily, we promote positive nonpartisan voter education, registration and get out the vote activities.

#### <u>ARTICLE IV</u>

#### Officers/Executive Board

The manner in which directors are elected or appointed shall be prescribed in chapter bylaws in accordance to the principles and policies set forth by the national A. Philip Randolph Institute, headquartered in Washington, DC.

# ARTICLE IX

#### Restrictions

This corporation is organized as a charitable and educational and research organization within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other provision of these articles, this organization shall not carry on any activities which are not permitted to be carried on by an organization exempt from taxation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons; provided, however, the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, hereof and to pay or reimburse the reasonable expenses of fundraising and carrying out the objectives of the corporation. Nothing herein shall be construed to preclude any director from receiving compensation for serving the corporation in any other capacity and receiving compensation therefore.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

This corporation is organized on a non-stock basis.

#### ARTICLE1X

# Dissolution

In the event of dissolution of this corporation, the residual assets of the corporation will be turned over to the national A. Philip Randolph Institute which themselves are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or corresponding sections of any prior or future United States Internal Revenue law. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is located, exclusively for such purposes, or to such organizations as the court shall determine.
