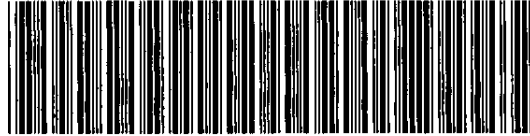

Article I Name

The name of the corporation shall be: SENIOR COMMUNITY RESOURCE, INC.

Article II Principal Office

The principal street address is 8635 River Homes Lane # 105, Bonita Springs, FL 34135.

The principal mailing address is 8635 River Homes Lane # 105, Bonita Springs, FL 34135.

Article III Purpose

The corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation is organized to establish a nonprofit agency that enables seniors to connect with available local services and resources. Information and referral specialists will be available to help seniors identify and receive services they may be eligible to receive. Senior Community Resource Inc will coordinate the services of nonprofit organizations, businesses, government, and individuals in our community to develop creative solutions that improve the lives of our senior citizens in the Lee County, Florida.

Article IV Manner of Election

In order to be eligible to serve as a director on the board of directors, the individual must be 18 years of age. Directors may be elected at any board meeting by the majority vote of the existing board of directors. Directors shall serve a term of one year. Board members may serve terms in succession. Terms or service will be staggered so that approximately half the number of directors will end their term in a given year.

Article VI Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VII Dedication of Assets

Upon the dissolution, termination, or winding up of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or

local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


