CHAPTER 4  
THE CONSTITUTION  
of the  
UNITED HOLY CHURCH OF AMERICA,  
INCORPORATED  
THE PREAMBLE

In order that we may wisely preserve the heritage transmitted to us, and also that we may prepare the way for more effective cooperation with other branches of the church of Christ in all that makes for the advancement of God's Kingdom among men, we the members of the United Holy Church of America, Inc., in accordance with methods of constitutional legislation established among us, do hereby ordain and establish this constitution.

ARTICLE I—NAME

The name of the Church shall be the United Holy Church of America, Incorporated.

ARTICLE II—OBJECT

The object of this organization is to establish and maintain within the United States of America

and in the uttermost parts and countries of the world a municipality of Holy convocations, assemblies, conventions, conferences, public worship, missionary and school work, orphan homes, manual and trades training schools and other operations auxiliary and incidental thereto; also religious resorts, with permanent and temporary dwellings for health, rest, Christian work and fellowship, and for the spiritual, moral and mental improvement of men, women, boys and girls.

### ARTICLE III

Any person who is a member of a church of the United Holy Church of America, Inc., of good moral character and accepts the provisions of the Articles of Faith of the United Holy Church of America, Incorporated, will be a member of this organization and shall be eligible to serve on any board, commission, or committee for which he or she shall be qualified.

### ARTICLE IV—GENERAL CONVOCATION

The General Convocation shall have full legislative powers over all matters relating to the organization, reserving unto itself any and all powers it does not expressly delegate to others;

and in the exercise of such powers shall have authority including, but not limited to the following:

1. To define and fix the conditions, privileges and duties of the members, ministers and officers, and for their removal.

2. To define and fix the powers and duties of Annual Convocations, Conventions, and Quarterly Meetings.

3. To provide for the organization, promotion and administration of the work of the Church outside of the United States of America.

4. To adopt a plan for the support of the bishops, to provide for the discontinuance of a bishop or a minister because of inefficiency or unacceptance.

5. To fix a uniform basis upon which bishops shall be elected by the General Convocation and to determine the number of bishops who may be elected.

6. To provide that each active bishop has some specific responsibility within the General Church and to provide a plan for the support of bishops.

7. To establish the boundaries of a new district convocation, taking into account the boundaries of existing convocational districts.

8. To establish boards, committees, commissions, etc. as the need may arise and to choose their membership as appropriate.
