**ARTICLES OF INCORPORATION  
OF  
THREE HEARTS DANCE, INC.**

The undersigned, acting as incorporator of Three Hearts Dance, Inc., a not for profit corporation, pursuant to the Florida Not For Profit Corporations Act, Florida Statutes Chapter 617, hereby adopts the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the corporation is: Three Hearts Dance, Inc. (the "Corporation").

**ARTICLE II: PRINCIPAL OFFICE**

The initial mailing and street address of the principal office of the Corporation in the State of Florida is:

**ARTICLE III: PURPOSE**

The purposes for which this corporation is organized are as follows:

A. to receive and to administer funds, and to operate exclusively for charitable, scientific, literary, education and/or religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended; and

B. other similar purposes not for pecuniary profit permitted under the laws of the State of Florida and particularly under the Florida Not For Profit Act.

**ARTICLE IV: DURATION AND EXISTENCE; EFFECTIVE DATE**

The Corporation will exist perpetually, commencing on the date of the filing of these Articles of Incorporation with the Florida Department of State.

**ARTICLE V: AUTHORIZED SHARES**

This Corporation is organized under a non-stock basis, and no shares of capital stock shall be issued.

**ARTICLE VI: REGISTERED AGENT & OFFICE**

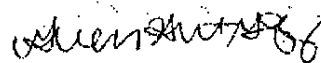

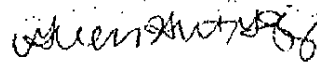
