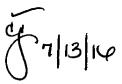

#### A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned, acting as the incorporator of a not-for-profit corporation under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation:

#### **ARTICLE 1: NAME**

The name of the Corporation shall be: **SPC ASABA ALUMNI USA, INC.**, hereinafter referred to as the "Corporation".

#### **ARTICLE 2: PRINCIPAL OFFICE AND MAILING ADDRESS**

The initial address of the principal office of the Corporation and the mailing address is **C/o 1911 NW 150 Ave, Ste. 202, Pembroke Pines, FL 33028** 

#### **ARTICLE 3: DURATION**

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

#### **ARTICLE 4: PURPOSES**

The Corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986, as amended. Not-withstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue code of 1986, (or the corresponding provision of any future United States Internal Revenue Law), or (2) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

#### **ARTICLE 5: RESTRICTION ON ACTIVITIES**

No substantial part of the activities of this corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in or intervene in including (the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

#### ARTICLE 6 REGISTERED OFFICE AND AGENT
