

ARTICLE I: NAME

The name of the corporation shall be: Kresearch, Corp.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 801 International Parkway 5th Floor, Lake Mary, FL 32746, US.

ARTICLE III: PURPOSE

This corporation is organized exclusively for charitable, religious, and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The specific purpose of the corporation is to conduct research, produce seminars, publications and consulting services to promote human and scientific development.

1. The corporation shall not distribute any gains or profits to the Directors. Officers or Members thereof, or to any individual, except as reasonable compensation for services actually performed in carrying out the corporation's charitable, religious, and educational purposes. The property, assets, profits, and net income of the corporation are irrevocably dedicated to charitable, religious, educational, and scientific purposes, no part of which shall inure to the benefit of any individual.
- 3. LOBBYING AND POLITICAL CAMPAIGNS: No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- 4. DISSOLUTION: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
