

Pursuant to the provisions of Section 617.1006, Florida Statutes, this *Florida Not-For-Profit Corporation* adopts the following amendment to its Articles of Incorporation:

Article V of the Articles of Incorporation is amended and re-stated to read:

Article V Board of Directors

- A. The affairs of the corporation shall be conducted under the authority and direction of the Board of Directors. The number of Directors shall be determined by the Bylaws but shall not be less than three (3) Directors and shall include the persons described in the next paragraph. Each Director must be a citizen of the United States and must have attained his or her twenty-first birthday.
 - B. The Directors of the Corporation shall include:
 - 1. The Vestry Finance Chairman of the Cathedral, who is initially Richard Wilkerson, or his/her designee;
 - 2. The Dean of the Cathedral, who is initially Dean Katherine Moorehead; and
 - 3. One Director, who shall be elected by the Members (the "<u>Project Director</u>," as further described in the Bylaws of the Corporation), who is initially Virginia Myrick.
- C. If at any time a vacancy occurs due to the lack of a successor office holder above or for any other reason, a successor Director shall be nominated by the remaining Directors or, if none, by the Members and shall be elected by the Members of the Corporation in the manner prescribed in the Bylaws.
