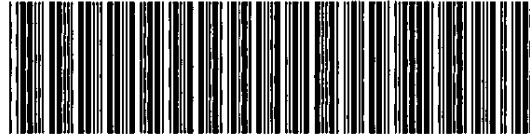

For the purposes of forming a Florida not-for-profit corporation pursuant to Chapter 617, Florida Statutes, the undersigned files these Articles of Incorporation and states as follows:

ARTICLE I
NAME

The name of the corporation is BUILDING OFFICIALS ASSOCIATION OF THE TREASURE COAST, INC.

ARTICLE II
MAILING ADDRESS

The address of the principal office is 100 N US 1, Fort Pierce, Florida 34954 and the mailing address is PO Box 1480, Fort Pierce, Florida 34954.

ARTICLE III
PURPOSE OF CORPORATION

The purposes for which this corporation is formed are as follows:

- A. To promote education to the corporation membership and the construction industry.
- B. To insure safe and secure buildings in which people of Florida may live and work, by promoting building regulations and administrative organization techniques and methods of their enforcement by local government.
- C. To allow the use of new materials and construction methods that have been approved by established procedures by the Building Official Association of Florida and the International Code Congress and to increase memberships' knowledge and understanding of such new materials and construction methods in their proper application.
- D. To correlate the activities of the Chapter with the International Code Congress.
- E. To promote and encourage uniform interpretation of building regulations.
- F. To maintain modern building regulations by submitting amendments, additions, and deletions to the regulations to the Florida Building Code and the International Code Congress.

ARTICLE IV
TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V
DESIGNATION OF REGISTERED AGENT

The initial Registered Agent is designated as EVANGELINE GRISSOM BRUHN, the Registered Agent of the corporation may be changed at any time by a vote of the Board of Directors without an amendment of these Articles.
