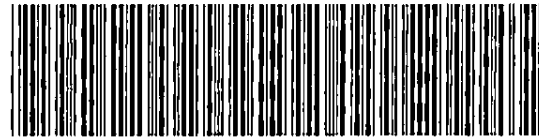

ARTICLE I - NAME

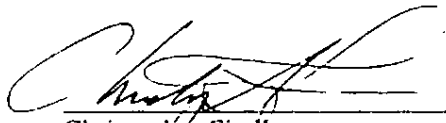
The name of the Corporation is "Florida Strong Action PAC, Inc."
