

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

SECRETARY OF CIME TALLAHASSEELED

ARTISTRY COMMUNITY ASSOCIATION, INC., A FLORIDA NOT-FOR-PROFIT CORPORATION

(Document Number N16000007122)

RECITALS:

- A. WHEREAS, SWFWMD has directed the Declarant to remove the existing Articles \$14.1(b) as a condition of SWFWMD Permit No. 43027848,005; and
 - B. WHEREAS, the Articles §12.1.3(a) provides:

Adoption. Prior to Turnover, the Declarant shall have the right to unilaterally amend these Articles without the joinder or approval of any member of the Board or any Member. No amendment to these Articles shall be effective without the written approval of the Declarant prior to Turnover; and

- **C. WHEREAS**, as of the adopted date hereof, Turnover has not occurred, and Declarant has not otherwise terminated its right to unilaterally amend the Articles; *and*
- **D.** WHEREAS, no members of the Board and no Association Members are entitled to vote on this Amendment; *and*

Now Therefore, pursuant to the provisions of §617.1006, *Fla. Stat.*, this Florida not-for-profit corporation adopts the following amendment(s) to its Articles of Incorporation:

- (a) <u>Underline</u> text signifies new and additional text.
- **(b)** Strikethrough text signifies deleted text.

ARTICLE XIV DISSOLUTION

- 14.1 In the event the Association is dissolved or otherwise ceases to exist:
 - (a) The control of, Maintenance obligations for, and/or right of access to, those portions of the property containing the Surface Water Management System and/or other Common Areas owned and/or Maintained by the Association or in which the Association has an easement or other interest, shall be conveyed or dedicated to an appropriate Governmental Authority or public utility, and if not accepted, shall be conveyed to a not-for-profit corporation

similar to the Association (any successor entity must comply with Rule 62-330.310, F.A.C., the Environmental Resource Permit Applicant's Handbook Volume 1, Section 12.3, and be approved by SWFWMD prior to the Association's termination, dissolution, or liquidation); and

- (b) Until such alternate entity assumes such-responsibility, all of the Owners shall be jointly and severally responsible for the operation and Maintenance of the portions of the Surface Water Management System and/or Common Areas for which the Association previously was responsible; and
- (b)(e) Except as may be otherwise provided by the terms of the Declaration, all remaining assets, or the proceeds from the sale of such assets, shall be apportioned among the Members, prorated to the number of votes attributable to each Member.
