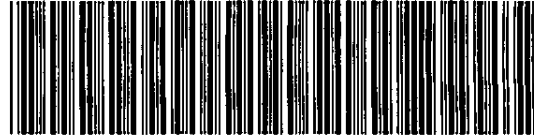

The purpose for which the corporation is organized is: to develop and govern American Legacy Charter School. This corporation is organized exclusively for charitable and educational purposes, including for such purposes the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code or any corresponding section of any future federal tax code. No proceeds of the corporation will enrich any individual, except that reasonable compensation may be paid in exchange for services to the corporation. If the corporation is dissolved, any assets remaining will be distributed to another corporation that serves a similar purpose and qualifies as a tax-exempt, charitable organization under the provisions of 501(c)(3) of the Internal Revenue Code.
