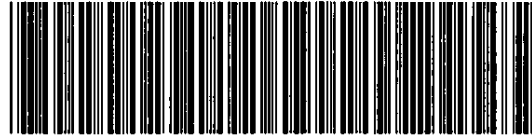

1. This is a Not For Profit corporation created in the State of Florida under Florida Statute 617.01201.
