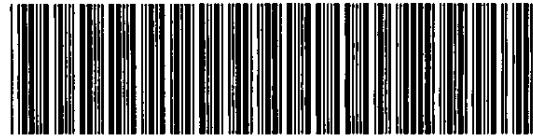

ARTICLES OF INCORPORATION OF
MIDWIVES ORGANIZED TO HELP ESTABLISH SELF-RELIANCE CORPORATION

The undersigned, a natural person over the age of eighteen years hereby certifies as follows:

ARTICLE I – NAME

The name of the corporation is Midwives Organized to Help Establish Self-Reliance Corporation, (hereinafter referred to as the "Corporation").

ARTICLE II – REGISTERED OFFICE ADDRESS

The principal office of the Corporation is to be located at 5700 E. Irlo Bronson Memorial Highway, Saint Cloud, FL 34771. The name and address in the Corporation's initial agent for service of process is: Brooke Schmoe, 5700 E. Irlo Bronson Memorial Highway, Saint Cloud, FL 34771.

ARTICLE III – INCORPORATOR

The name and address of the Incorporator is: Tolan Solomon, 4179 Blowing Rock Blvd. Lenoir, NC 28645

ARTICLE IV – PURPOSE

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purposes of the Corporation are to provide:

Midwifery care to low income and homeless families.

The Corporation shall not be conducted or operated for profit and no part of the net earnings of the Corporation shall inure to the benefit of any individual, nor shall any of the profits or assets of the Corporation be used other than for the purposes of the Corporation.

ARTICLE V – MANNER OF ELECTION

The manner in which the directors are elected and appointed:

Any directors must receive a majority vote by the current elected Officers.

ARTICLE VI -- INITIAL OFFICERS AND/OR DIRECTORS

ARTICLE VII -- EXEMPTION REQUIREMENTS

At all times the following shall operate as conditions restricting the operations and activities of the Corporation:

1. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.
2. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
3. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII -- DURATION/DISSOLUTION

The duration of the corporate existence shall be perpetual. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent

jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

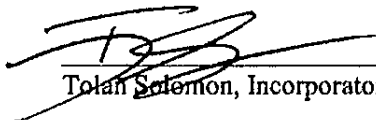
