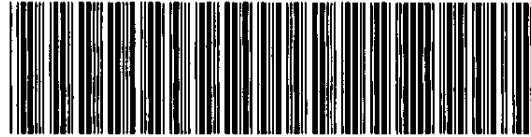

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt s) the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation is: **Ministerio Nuevo Amanecer en la Gloria del Reino de Stuart, Inc.**

The principal place of business of this corporation is: **2827 SE Delmar St, Stuart, FL 34997**

ARTICLE II

The period of duration of this corporation is perpetual unless dissolved according to law. The corporation starting day is June, 2016.

ARTICLE III

The purposes for which the corporation is organized are:

1. To encourage and promote the evangelization of the world.
2. To encourage and promote the worship of God.
3. To encourage and promote the edification of believers.
4. To establish and maintain such departments as may be necessary for the spreading of the gospel.

8. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c) and 170 (c) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.
