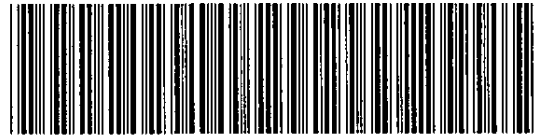

Articles of Incorporation

Article I: Name

Water and Youth Safety Pensacola, Inc.

Article II: Location

4640 Regency Court Pensacola, FL 32504

Article III: Purpose

The general nature of the objects and purposes of this corporation shall be:

A. To organize, promote, coordinate, and support all aspects of this nonprofit corporation's water safety initiative and to do all things necessary, implied, helpful, appropriate, or suitable for the accomplishment of the purposes set forth herein, subject however, to any limitations set forth herein or imposed by law.

B. The corporation shall have the powers to sue and be sued, contract, acquire in any lawful manner real and personal property, to possess, use, improve, sell, mortgage, lease, any part thereof, and to use its funds for any purpose not inconsistent with its corporate purpose and powers. The corporation shall have all the powers and authority which now or hereafter may be conferred by law and to do all and everything necessary, suitable and proper for the accomplishment of the purposes set forth herein.

C. The corporation is organized exclusively for charitable, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

D. Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States revenue law or (b) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.

E. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or
