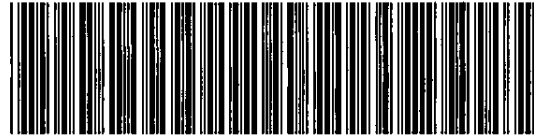

Article VIII: Living Learning Libraries, Inc., will not discriminate in its educational service based on race or ethnicity.

Article IX: Living Learning Libraries, Inc., is dedicated to the advancement of education, within the meaning of Section 501(c)(3), or any corresponding section of any future federal tax code, and we will limit our purposes to exempt activities.

Article X: Upon dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the IRS Code, or corresponding section of any future federal tax code.

Article XI: Living Learning Libraries, Inc., will not expressly engage, otherwise than as an insubstantial part of our activities, in activities which in themselves are not in furtherance of one or more exempt purposes.

Article XII: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes described in Section 501(c)(3).

Article XIII: No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on a) by a corporation exempt from federal income tax under Section 501(c)(3) of the IRS Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the IRS code, or the corresponding section of any future federal tax code.
