Article IV

Purpose of Corporation – Paragraph 1

Red Hills Journalism Foundation corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under 501 (c)(3) of the Internal Revenue Service Code, or corresponding section of any future federal tax code.

Article IV

Purpose of Corporation – Paragraph 4

Upon the dissolution of the Red Hills Journalism Foundation corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
