ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

REBEKAH NORTON, Secretary of ESTERO POINTE COMMUNITY ASSOCIATION, INC., a Florida corporation not for profit ("Association"), does hereby certify under the seal of the Association as follows:

1. The Association was originally incorporated on August 9, 2016, Document Number N16000007828, under Chapter 617 of the laws of the State of Florida.
2. The Declaration of Covenants, Conditions, Restrictions and Easements for Estero Pointe was recorded on October 27, 2016, as Instrument # 2016000228419, of the Public Records of Lee County, Florida.
3. Article XIII, Section B, of the Articles provides that after the First Conveyance and prior to the Turnover Date the Articles may be amended solely by a majority vote of the Board, without the prior written consent of the Members, at a duly called meeting of the Board.
4. The Board of Directors of the Association is desirous of amending the Articles to correct a scrivener's error.
5. The following Amendment was adopted by the Board of Directors by Written Consent in Lieu of Meeting on May 26, 2020, and there are no members entitled to vote on the Amendment.

NOW, THEREFORE, the Articles are hereby amended as follows:

1. Article V, Subsection 1 of Section D, of the Articles is hereby amended to read as follows:

D. The Association shall have two (2) classes of voting membership:

1. Class "A" Members shall be the Owners of Lots in ~~Pebble Point~~ **Estero Pointe**, with the exception of Declarant while Declarant is a Class "B" Member, each of whom shall be entitled to one (1) vote for each Lot owned.

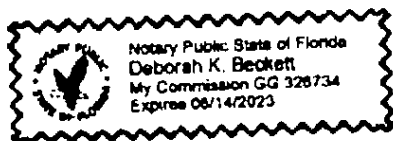
