**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF**

**DR. LOUIS J. SCALA MEMORIAL FOUNDATION, INC.**

Dr. Louis J. Scala Memorial Foundation, Inc. (the "Corporation"), a Florida corporation-not-for-profit, organized and existing under the laws of the State of Florida pursuant to Articles of Incorporation filed on August 10, 2016 and having no members, adopts the following amendments to its Articles of Incorporation, as of the 4<sup>th</sup> day of November 2016, pursuant to the unanimous written action of all of the Directors of the Corporation in lieu of a meeting:

**RESOLVED**, that Article 7 of the Articles of Incorporation filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:

**"Article 7 – Officers**

The officers of the Corporation shall be a President, Secretary and Treasurer, and such other officers as may be provided by Bylaws adopted for the Corporation. Officers shall be elected by the Board of Directors in the manner set forth in Bylaws adopted for the Corporation; provided that the initial officers shall be as follows:

**RESOLVED**, that Article 8 of the Articles of Incorporation filed with the Secretary of State of the State of Florida be amended to read in its entirety as hereinafter set forth:

**"Article 8 – Directors**

The affairs of the Corporation shall be managed by a Board of Directors, members of which shall be elected in accordance with Bylaws adopted for the Corporation. The number of members of the Board of Directors shall be fixed as set forth in Bylaws adopted for the Corporation; provided, however, the Corporation shall never have less than three (3) members of the Board of Directors.
